#### **Relaxations and Concessions:**

- 1. For PwD category Candidates, age is relaxable by 10 years. Persons suffering from not less than 40% of the relevant disability shall only be eligible for the benefit for PwD.
- The age concession to the PwD shall be admissible irrespective of the fact whether the post is reserved for person with disabilities or not, provided the post is identified suitable for the relevant category of disability.
- 3. The above notified position is identified suitable for the disabilities as indicated under the relevant provisions of Rights of Persons with Disability Act (RPwD) 2016 and subsequent rules on the matter:
  - a) Locomotor disability (OL, BL & OA) (b) Leprosy cured (c) Dwarfism and (d) Acid Attack Victims.
- 4. Upper age limit is relaxed by 5 years for the candidates who had ordinarily domiciled in the state of Jammu & Kashmir during the period from 01/01/1980 to 31/12/1989.
- 5. Age relaxation for Ex-Servicemen will be as per Central Government Rules.
